



## Christ the King EDP & Aftercare Payment Options 2017-2018 School Year

EDP (after school care from 2:50pm-6:00pm daily) & Aftercare (after preschool care for 2's, 3's & 4's from 11:00am-2:50pm daily)

### Extended Daycare Program Rates

EDP is a state licensed after school program available for students PreK-8<sup>th</sup> grades. Due to state staffing requirements, we are asking that you register in advance for the number of days you will need after school care. Students will be provided a snack, play time, arts & crafts, and study hall while at EDP. All children must register for the Aftercare/EDP program and complete the number of days these services will be needed.

#### **Payment Options:**

1. Payment in full for EDP by August 16, 2017: \$1,890.00 (one child/five days a week). The business manager can provide discounted amounts for multiple children.
2. A monthly payment option (September through May) through the FACTS tuition payment plan. If parents are not paying tuition through FACTS, please go to [www.ctkschool.net](http://www.ctkschool.net) and click on Admissions then the Tuition link and follow instructions to set up a new FACTS account for EDP & Aftercare. If this is not set up, you will be charged the \$15.00 daily rate. The draft will be deducted on the 10<sup>th</sup> of the month.

**Drop in rate is \$15.00 per child/day and is to be paid on the day of use, if not, you will be billed for the amount owed plus your regular scheduled EDP/Aftercare schedule.**

#### Payment and Late Charges

- Students who come more days than are indicated, will be billed the \$15.00 per day rate until you have emailed the business manager, David Stromquist at [dstromquist@ckslex.org](mailto:dstromquist@ckslex.org). If you decide you are not going to use aftercare/extended daycare on the days indicated, you must provide notice in writing by the 20<sup>th</sup> of the month in order for payment arrangements to be adjusted through FACTS.
- No adjustments will be made for absences or illnesses.
- There is a late charge of \$1.00 per minute after 6:00pm. This additional fee will be billed to you.

### Aftercare Program Rates:

Students who stay for aftercare in the 2 year old program, 3 year old program or the 4 year old program will also need to register for the number of days they will be in attendance.

#### **Payment Options:**

1. Payment in full for Aftercare by August 16, 2017: \$2,867.40(one child/five days a week). The business manager can provide discounted amounts for multiple children.
2. A monthly payment option (September through May) through the FACTS tuition payment plan. If parents are not paying tuition through FACTS, please go to [www.ctkschool.net](http://www.ctkschool.net) and click on Admissions then the Tuition link and follow instructions to set up a new FACTS account for EDP & Aftercare. If this is not set up, you will be charged the \$25.00 daily rate. The draft will be deducted on the 10<sup>th</sup> of the month.
3. A 10% discount is available to multiple children in the 2yr. old, 3yr. old and 4yr. old Aftercare program.
