Application Fee	\$270 for all new families, plus \$20 each for multiple students - <i>non-refundable</i>
Re-enrollment Deposit	\$300 for each family returning- <i>applied toward tuition balance</i>
Supply Fee	\$250 per student (PK1- 8th Grade)- <i>non-refundable</i>
Snack Fee	\$125 per student (PK1-PK4)- <i>non-refundable</i>

Payment Options:

- 1. Payment in Full:** By May 1, 2023
- 2. Monthly Payment Option:** May, 2023 through April, 2024, payments paid through **FACTS Tuition Account**. The school will handle rolling active FACTS accounts forward for the new year, so families re-enrolling should not create a new FACTS account.

Tuition Policy

- Christ the King School tuition via monthly payments is drawn from the payment method you specify (bank account or credit/debit card) on the 5th or 20th day of each month, from May, 2023, through April, 2024, through your FACTS account.
- A late fee of \$25/month will be assessed for each payment that has not been received within 10 days after it is due.
- Families whose FACTS account is past due on tuition, EDP, Aftercare, Cafeteria, or supply fees for the current year will not be allowed to re-enroll for the new school year until the balances for the current year are paid.
- The FACTS account for any family that selected the pay-in-full option for the current 2023-24 school year but did not pay in full by May 1, 2023 (the pay-in-full deadline for the current school year) will be converted to a FACTS monthly payment plan, requiring payment-method information to be established in your FACTS account at the time of re-enrollment.
- For withdrawal of students from enrollment anytime after July 1st, unless extenuating circumstances apply as determined by the Principal of CKS, no monthly FACTS tuition payments are refundable once they have been drafted through your FACTS account, and refunds to families who paid in full will be prorated as of the date of withdrawal.
