<b>Re-enrollment Deposit</b>	\$300 for each family returning
<b>Supply Fee</b>	\$250 per student (PK1- 8th Grade)

**Payment Options:**

- 1. Payment in Full:** Within 30 days of Enrollment Date
- 2. Monthly Payment Option:** May, 2022 through April, 2023 payments paid through **FACTS**. The school will handle rolling active **FACTS** accounts forward for the new year, so families re-enrolling should not create a new **FACTS** account.

**Tuition Policy**

- Christ the King School tuition for monthly payments is due on the 5<sup>th</sup> or 20<sup>th</sup> day of each month, from May, 2022, through April, 2023, through your **FACTS** account.
- A late fee of \$25/month will be assessed to all accounts on which payment has not been received within 10 days after it is due.
- Families whose **FACTS** account is past due on tuition, EDP, Aftercare or supply fees for the current year will not be allowed to re-enroll for the new school year until the account for the current year is brought current.
- The **FACTS** account for any family that selected the pay-in-full option for the current 2022-23 school year but did not pay in full by May 1, 2022 (the pay-in-full deadline for the current school year) will be converted to a **FACTS** monthly payment plan, requiring banking information to be established in your **FACTS** account at the time of re-enrollment.
- For withdrawal of students from enrollment anytime after July 1st, unless extenuating circumstances apply as determined by the Principal of CKS, no monthly **FACTS** tuition payments are refundable once they have been drafted through your **FACTS** account, and refunds to families who paid in full will be prorated as of the date of withdrawal.
